This course provides an introduction to international economics, concentrating on trade theory and policy. In the lecture we will discuss the main theoretical approaches that explain the structure and volume of trade as well as important issues in trade policy. The proseminars deal with additional topics like the relationship between trade and environment or trade and infrastructure.

To 1.:

To 2.:

- Each test takes approx. 30 minutes.
- Each test contains 6 questions.
- The answer to each question is worth up to 2 points.
- All in all there are 24 points achievable, from 12 on you are graded positively.

To 3.:

- You may form groups of four to present a particular topic (length of presentation: 60 minutes).
- The use of additional literature is appreciated.
