at the Faculty of Philosophy and History of the University of Innsbruck

### § 1 Qualification profile

- (1) The Bachelor's Programme European Ethnology is grouped among the Humanities and Cultural Sciences.
- (2) **The qualification profile** of the Bachelor's Programme European Ethnology aims at conveying scientifically well-founded analysis, interpretation and reflection skills, which enable students to examine cultural phenomena and popular identity models as well as their contextualization with regards to discourse-analysis and practice-theory.

Students learn about European Ethnology in its folkloristic, ethnological and cultural-anthropological subject tradition, and they get an overview of its specific question, interest, source and method profile, which distinguishes it from other cultural scientific disciplines. This also includes the interconnection of historical and current issues as a special characteristic of European Ethnology.

Students thus acquire abstraction abilities and learn to think in a multidisciplinary way.

In this context, they develop awareness of the questions of social constructions such as historicity, modernisation, identity politics, globalisation, gender etc., and they learn to relativise their own point of view. With its comparative and cultural-relativistic perspective, the Bachelor's Programme European Ethnology also promotes constructivist thinking and enables students to critically reflect on their own assumptions and categories of perception.

Key learning outcomes: The objective of the Bachelor's Programme European Ethnology is to prepare graduates for a wide range of cultural and social-scientific occupational and vocation- al fields. By the end of the study programme, students develop critical reflection skills which enable them to apply European-ethnological knowledge to cultural problems by formulating and substantiating scientific arguments. Graduates are able to collect and interpret relevant data by using subject-specific methods and to support with this scientific positions with their social and ethical issues, to questions them and to convey this outcomes to experts and well as laypersons.

**Key qualifications and soft skills**: In examining European-ethnological issues, graduates establish and expand verbal and written skills by communicating and presenting research results, skills of information management and self-management as well as social skills and teamwork.

(3) The Bachelor's Programme European Ethnology prepares graduates for a wide range of occupational fields, such as in documentation, collections, museums and exhibitions, libraries and publishing, public relations, cultural journalism, adult education, developmental work, cultural

- policy and administration, tourism as well as intercultural social work and cultural management.
- (4) The Bachelor's Programme European Ethnology is characterised by a special **research orientation**. Students are carefully introduced to specific research processes as well as issues of interdisciplinarity based on examples of cultural contact and cultural transfer.

## § 2 Scope and duration

The Bachelor's Programme European Ethnology covers 180 ECTS-Credits, with a duration of six semesters.

### § 3 Types of courses and maximum number of participants

- (1) Courses without continuous performance assessment:
  - 1. **Lectures** (VO) are courses held in lecture format. They introduce the research areas, methods and schools of thought for a given subject. No maximum number of participants
  - 2. **Studies orientation courses** (SL) provide an overview of the study programme and its structure. They give students an objective basis to assess their decision to pursue their chosen subject. Compulsory attendance. Maximum number of participants: 30
- (2) Courses with continuous performance assessment:
  - 1. **Introductory seminars** (PS) introduce students interactively to scientific literature through the treatment of selected issues. They convey knowledge and methods of academic work. Maximum number of participants: 30
  - 2. **Practical courses** (UE) focus on the practical treatment of concrete scientific tasks within an area. Maximum number of participants: 30
  - 3. **Lectures with practical elements** (VU) focus on the practical treatment of concrete scientific tasks that are discussed during the lecture parts of the course. Maximum number of participants: 30
  - 4. **Excursions** (EX), conducted outside the premises of the university, serve to demonstrate and deepen course contents. No maximum number of participants.

### § 4 Allocation of places in courses with a limited number of participants

In courses with a limited number of participants, course places are allocated as follows:

- 1. Students for whom the study duration would be extended due to the postponement are to be given priority.
- 2. If the criteria in Z 1 do not suffice, first, students, for whom this course is part of a compulsory module are to be given priority, and second, students of for whom this course is part of an elective module.

### § 5 Programme structure

- (1) Compulsory modules covering 150 ECTS-Credits must be passed. The study programme has a non-consecutive structure. It is recommended to pass the modules "Introduction to Research Fields and Positions in European Ethnology" and "Methods and Approaches of European Ethnology" during the first two semesters.
- (2) Elective modules covering 30 ECTS-Credits must be passed.

### § 6 Studies Induction and Orientation Stage

- (1) Within the scope of the Studies and Orientation Stage, which takes place in the first semester, the following course examinations must be passed:
  - 1. Introduction to Research Fields and Positions in European Ethnology (CM 5 lit.a/2 h/5 ECTS-Credits),
  - 2. VO Fundamentals of Cultural Studies (CM 1/2 hrs/5 ECTS-Credits).

- (2) Successful passing of all exams of the Studies Induction and Orientation Stage entitles to passing all further courses and examinations as well as to writing the Bachelor's Thesis.
- (3) Before successful completion of the Studies Induction and Orientation Stage courses amounting to 20 ECTS-Credits may be passed. The requirements specified in the curriculum must be met.

### 3. Individual choice of specialisation (maximum of 20 ECTS-Credits)

For individual specialisation modules of the curricula of the bachelor programmes of the University of Innsbruck corresponding to 20 ECTS-Credits are to be chosen according to §54 par. 1 of the Universities Act. This module aims at expanding the study programme and at acquiring additional qualifications. The prerequisites specified by the respective curricula must be met.

4. Instead of the compulsory module according to § 7 par. 2 no. 3 (Interdisciplinary/Non-Subject-Speficic Skills) and the Individual Choice of Specialisation according to § 7 par. 2 no. 3, a Minor for Bachelor's Programmes can be completed according to free places. Minors are defined modules from other subject disciplines amounting to 30 ECTS-Credits; they are announced in the University of Innsbruck's Bulletin.

### § 8 Bachelor's Thesis

- (1) A Bachelor's Thesis on a theme in European Ethnology corresponding to 10 ECTS-Credits must be written within the scope of compulsory module 15. The thesis is supervised by the respective course lecturer.
- (2) The Bachelor's Thesis is a written paper that shows that the students are able to independently apply the theoretical and methodological instruments used in European Ethnology for discussing a specific question.
- (3) The Bachelor's Theses are to be submitted in paper form and in digital version. The form of the submission of the digital version is to be determined by the Director of Studies.

### § 9 Examination Regulations

- (1) The assessment of performance of a module (module examination) is to be carried out by course examinations. Course examinations:
  - 1. Examinations that assess the knowledge and skills covered by an individual lecture and where the performance is assessed by a single examination at the end of the course. If a reading list is specified within the scope of a lecture, it is part of the examination. The course lecturer must communicate the examination method (written or oral) before the start of the course.

- 2. Courses with continuous performance assessment, for which the performance assessment is based on regular written and/or oral contributions by the participants. The course lecturer must communicate the assessment criteria before the start of the course.
- (2) Elective module 2 is assessed on the basis of a report that must be submitted to the Director of Studies. Positive assessment reads "participated with success", negative assessment reads "participated without success".

#### § 10 Academic Degree

Graduates of the Bachelor's Programme European Ethnology are awarded the academic degree "Bachelor of Arts", abbreviated "BA".

#### § 11 Coming into force

- (1) This curriculum comes into force on 1 October 2012.
- (2) The modification of the curriculum in the version of the University of Innsbruck Bulletin of 18 June 2015, Issue 65, No. 493 comes into force on 1 October 2015 and is to be applied to all students.
- (3) § 6 comes out of force at the end of 31 December 2015.
- (4) § 6 in the version of the University of Innsbruck Bulletin of 2 May 2016, Issue 24, No. 368 comes into force on 1 October 2016 and is to be applied to all students commencing their study programme as of the 2016/2017 winter semester and to all students, who have not yet passed the courses of the studies induction and orientation stage according to the previous regulations.
- (5) §9 par. 1 no. 1 in the version of the University of Innsbruck Bulletin of 2 May 2016, Issue 24, No. 368 comes into force on 1 October 2016 and is to be applied to all students.
- (6) § 7 para. 2 no. 4 in the version of University of Innsbruck Bulletin of 25 May 2021, Issue 71, No. 793 come into effect as of 1 October 2021 and are to be applied to all students.

After that point in time more courses and examinations may only be taken after successful completion of the whole studies induction and orientation stage.
