# Curriculum for the **Bachelor's Programme in German Philology**at the Faculty of Humanities 2, University of Innsbruck

## § 1 Profile and programme objectives

- (1) The Bachelor's Programme in German Philology is grouped among the Humanities and Cultural Sciences.
- Educational objective: The objective of the Bachelor's Programme German Philology is scientific (2) examination of German language and literature, its development and functions in present and history as well as the cultural, social and anthropological-symbolic processes they are embedded in. Thus, language and literature are to be understood as comprehensive cultural phenomena which help to recognise, understand and form them and foster reflection about social and cultural processes, also in view of future development; a special emphasis is put on the gender aspects which also characterise language and literature in our culture. Thus, besides sound knowledge of historical, systematic and pragmatic aspects of language and literature and an insight into conveyance of literature in practice, knowledge of the media, their structures, action mechanisms and creative possibilities require considerable space within the Bachelor's Programme in German Philology. Studying the fundamentals and characteristics of oral and written communication and acquisition of high level oral and written language skills are other high priority objectives. As completion of the study programme is prerequisite for further scientific study programmes, teaching is scientific-based with a large diversity of theory; however, profession-relevant components in terms of practice-orientation and thus issues of teaching language and literature are also highly considered.

## (3) Qualification profile:

- General: The career opportunities, which the Bachelor's Programme in German Philology
  prepares for, are not allocated to one particular profession field. However, the examination with
  language and literature as forms of shaping the world enable graduates for diverse and
  heterogeneous requirements of the modern vocational world. The analysis and reflection of
  linguistic and cultural evidence raises their awareness for perceiving and examining social and
  cultural processes in the present and future.
- 2. Key qualifications: Scientific as well as practice-oriented examination with German language and literature offer competences that enable flexibility and mobility in a time of accelerated change. The involvement with the complex semiotic systems of language and literature require analytical-logical as well as synthetic approach and train logical thinking, recognition of types and patterns and their methodically appropriate reflection. The aesthetic and creative aspect of language and literature promotes aesthetic sensitivity and the potential for creative solutions. Apart from critical faculty and thinking in structures and alternatives, students acquire the ability of stringent argumentation and coherent description of scientific results as well as other facts, and they master important communication and presentation techniques and are able to share this knowledge in terms of soft skills. The study programme also imparts techniques of information procurement and evaluation (by the latest information technologies) and the ability

- to plan and structure methods and procedures. The programme requires a large amount of individual initiative and self-organisation. The courses promote the development of social skills such as cooperation and the capacity for teamwork, and communication skills, critical faculty and dealing with criticism.
- 3. Subject-specific skills: Graduates of the Bachelor's Programme in German Philology are expected to safely and situation-adequately master language and style norms and aesthetic norms as well as to recognize and correct norm irregularities. This includes language criticism as stylistic judgement as well as text production competence beyond scientific and subject-specific texts. Dealing with changing functions of literature in past and present also promotes the understanding and interpreting of historical-social contexts. It also promotes the comprehension of different thought and behaviour patterns. By encouraging the students' self-reflection, the literature studies have an emancipatory impact. Science-driven intensive examination with language in its historical and cultural context promotes the understanding of its function, functioning, and development in past and present, in the human socialisation process and the individual learning experiences. It creates and promotes language awareness and qualifies for the recognition of imprecise and/or manipulative use of language.
- 4. Key qualifications and soft skills: These are qualifications which students acquire in addition to their subject-specific competences and which qualify them to undertake vocational tasks in different occupational fields. Special emphasis is to be given to:
  - a) Written and oral expression: During their studies, students have to write various works, give presentations in courses and discuss work results. In this context, they also learn to present different contents, to outline complex issues in a comprehensive and convincing manner, to defend their own point of view, to criticize other views, to ask specific questions, and to give precise answers. One of the key qualifications is thus communicative competence.
  - b) The ability to clear rigid thought patterns by thinking in alternative ways and to be open for unconventional and creative solutions: Intense critically reflected dealing with specialist literature and different doctrines is particularly suitable for developing this ability.
  - c) Systematic approach to new tasks: In linguistics, literature and cultural science, texts are subject to a scientific analysis. In this context, students learn to specifically and individually solve problems and critically deal with individual solution strategies.
  - d) Thinking in contexts: By linking the subjects of German with other science fields and neighbouring disciplines, students are able to think in contexts and to consider several aspects of the tasks to be accomplished.
  - e) Independence: During their studies, students are supposed to find information and acquire knowledge autonomously. Independent scientific work requires and promotes the ability to organize one's own work efficiently and to accomplish it proactively.
  - f) Gender competence: The analytical examination with literary and other language certificates also enables students of German Studies to recognize and name gender aspects.
  - g) Intercultural and cross-cultural skills: Students are able to appropriately deal with other cultures and to understand and interpret their cultural processes and products adequately.
  - h) Team skills: These are developed and promoted by partner and group works.
  - i) Orientation skills: Knowledge of media and literary scene facilitates the orientation on the job market.
- 5. Occupational profiles and career opportunities: The Bachelor's Programme German Philology qualifies graduates for all occupational fields of cultural life. They are prepared for a wide range of activities and careers in publishing, media, bookstores, public libraries, proofreading and editorial work, journalistic and publishing activities in print media, radio, television and new media as well as in public relations or in the tourism industry. In addition to activities in cultural administration and mediation, the study programme prepares for occupational fields in international cultural and educational change or in public and private adult education as well as in public relations.

## § 2 Scope and duration

The Bachelor's Programme in German Philology covers 180 ECTS-Credits, with a duration of six semesters.

## § 3 Courses and numbers of participants

- (1) Courses without continuous assessment:
  - 1. **Lectures** (VO) deal with main and/or specific topics of German as well as relevant methods and doctrines. No max. number of participants.
  - 2. **Study orientation course** (SL) conveys an overview on the main contents of the study programme, and it forms the basis for the decision to choose the study programme. Study orientation courses are with compulsory attendance. The maximum number of participants: 30
- (2) Courses using continuous assessment:
  - 1. **Seminars** (SE) are courses for advanced scientific discussion. The participants are required to perform scientific work independently, particularly in form of a presentation and a written piece of work or equivalent performances. Maximum number of participants: 30
  - 2. **Introductory seminars** (PS) convey basic knowledge of scientific working, introduce subject literature and exemplary treat issues of the subject in presentations, discussions and smaller written contributions (of approx. 3,500 words) or equivalent performances. Maximum number of participants: 30
  - 3. **Practical courses** (UE) offer scientifically well-founded language training. Maximum number of participants: 25
  - 4. **Lecture-practical courses** (VU) serve as systematic acquisition, implementation and specialisation of scientific contents. Maximum number of participants: 30
  - 5. **Excursions** (EX) serve to on-site demonstration and specialisation of teaching. Maximum number of participants: 30

## § 4 Allocation of places in courses with a limited number of participants

In courses with a limited number of participants, course places are allocated as follows:

- 1. Students for whom the study duration would be extended due to the postponement are to be given priority.
- 2. If the criteria in Z 1 do not suffice, first, students of the Bachelor's Programme in German Studies and of the Secondary School Teacher Accreditation Programme in German, for whom this course is part of a compulsory module are to be given priority, and second, students of for whom this course is part of an elective module.

#### § 5 Stay abroad

A stay abroad with a duration of at least four months is strongly recommended. The objective of the stay abroad is international experience and to broaden the linguistic and cultural competence of the mother tongue and other linguistic environments.

#### § 6 Programme structure

- (1) Compulsory modules from the following five Areas of Competence with a total of 140 ECTS-Credits are to be taken:
  - Basics (30 ECTS-Credits)
  - Language Use (15 ECTS- Credits)

- Linguistics (40 ECTS- Credits)
- Literary Studies (40 ECTS- Credits)
- Cultural Studies (15 ECTS- Credits)
- (2) Elective modules with a total of 25 ECTS-Credits from min. two and max. three of the following Areas of Competence are to be taken. In one of the chosen Areas of Competence 5 ECTS-Credits can be replaced by an internship:
  - Language Usage
  - Linguistics
  - Literary Studies
  - Cultural Studies
  - Languages
  - Non-suspect-specific and Interdisciplinary Skills
- (3) Two bachelor's theses with a total of 7.5 ECTS-Credits are to be completed, which are to be completed in addition to the ECTS-Credits awarded of the relevant bachelor's theses courses.

## § 8 Studies Induction and Orientation Stage

- (1) The Studies Induction and Orientation Stage covers one semester (30 ECTS-Credits) and offers students an overview of the main contents of the degree programme and its structure in order to provide a factual basis to assess the decision to pursue the chosen field.
- (2) The Studies Induction and Orientation Stage requires the following course examinations, which may be repeated twice, to be completed successfully:
  - 1. SL Written Language (compulsory module 10 lit. a/1 SST/2.5 ECTS-Credits)
  - 2. SL Introduction to Interpreting Literary Texts (compulsory module 17 lit. b/1 SST/2.5 ECTS-Credits)

(3) Passing the examinations specified in paragraph 2 permits students to attend all further courses and take all examinations following the Studies Induction and Orientation Stage and to write a bachelor's thesis as described in the curriculum. Registration requirements specified by the curriculum are to be followed.

#### § 9 Bachelor's Theses

- (1) Two bachelor's theses with a total of 7.5 ECTS-Credits each are to be completed. Both theses are to be written in German and have to be subject-specific.
- (2) The bachelor's theses are to be completed within courses using continuous assessment from the compulsory modules 13 to 15, 19, 22, 24, 25 or from a chosen elective module of Literary Studies or Cultural Studies of the Bachelor's Programme in German Studies and are to be supervised by the lecturer of the respective course. The performance of the bachelor theses is to be delivered in addition to the relevant bachelor's theses courses.
- (3) The bachelor's theses are to be submitted in paper form and in digital version. The form of the submission of the digital version is to be determined by the Director of Studies.

## § 10 Examination Regulations

The assessment of performance of a module (module examination) is to be carried out by course examinations, Course examinations are:

- 1. Examinations that assess the knowledge and skills covered in an individual lecture or in the studies induction and orientation stage which course assessment is based on a single examination at the end of the course. If a reading list is determined in a lecture, it forms part of the examination material. Before starting the course, the course lecturer shall specify and declare which type of examination (written and/or oral) will take place.
- 2. Courses with continuous assessment, for which course assessment is based on regular written and/or oral contribution by participants. Before starting the course, the course lecturer shall specify and declare which type of examination will take place.

## § 11 Internship

- (1) In order to test and apply the knowledge and skills acquired or as an orientation on the conditions of professional practice as well as in order to achieve additional qualifications, the students of the Bachelor's Programme in German Studies have the opportunity of taking an internship with a total of 120 hours instead of an elective modules (with a total of 5 ECTS-Credits).
- (2) The internship can be taken no earlier than after completion of the second semester. It is recommended to take the internship from the fourth semester. Before starting the internship, permission of the Director of Studies shall be applied for.
- (3) The internship shall be taken in an institution with subject-specific activities, e.g. media (print media, radio, TV, new media), publishing, corporate communication/advertising, PR work (e.g. politics) or language teaching (German as a foreign language), in literary archives or houses of literature, publishing houses or a company (advertising, public relations).
- (4) A certificate of the institution stating duration, scope and content of the practical work performed shall be submitted; besides, a report shall be elaborated.

#### § 12 Academic Degree

Graduates of the Bachelor's Programme in German Studies are awarded the academic degree "Bachelor of Arts", abbreviated "BA".

## § 13 Validity and Effect

- (1) The curriculum is effective as of 1 October 2009.
- (2) §§ 3, 7, 10 and 14 in the version published in the University of Innsbruck Bulletin of 8 June 2011, Issue 26, No 454, is effective as of 1 October 2011 and applies to all students.
- (3) § 8 in the version published in the University of Innsbruck Bulletin of 8 June 2011, Issue 26, No 454, is effective as of 1 October 2011 and applies to all students beginning their degree programme as of winter semester 2011/2012.
- (4) § 8 in the version published in the University of Innsbruck Bulletin of 8 June 2011, Issue 26, No 454, ceases to be effective at the end of 30 September 2014.

## § 14 Transitory Provisions

- (1) Regular students who have commenced the Diploma Programme in German Philology at the University of Innsbruck (curriculum in the version published in the University of Innsbruck Bulletin of 10 September 2001, Issue 65, No 828) before 1 October 2009 are entitled from this point in time onwards to complete the first part of this study programme within a maximum of five semesters and second part of this study programme within a maximum of seven semesters.
- (2) If a part of the Diploma Programme in German Philology is not completed within the specified time then the current curriculum of the Bachelor's Programme in German Studies will apply. Students are entitled to change to the curriculum of the Bachelor's Programme in German Studies at any time on a voluntary basis.
- (3) Course examinations according to the Bachelor's Programme in German Studies (curriculum in the version published in the University of Innsbruck Bulletin of 28 April 2009, Issue 78, No 271) correspond to the course examinations of the curriculum in the version published in the University of Innsbruck Bulletin of 8 June 2011, Issue 26, No. 454, as follows:
