#### **Curriculum for the Master's Programme Philosophy at Faculty of Catholic Theology of the University of Innsbruck**

#### **§ 1 Qualification profile and programme objectives**

- (1) The Master's Programme Philosophy at Faculties of Catholic Theology serves the purpose of ensuring a philosophical education that builds on the Bachelor's Programme Philosophy at Faculties of Catholic Theology in consideration of the basic religious questions of the human person.
- (2) The Master's Programme Philosophy at Faculties of Catholic Theology provides students with a highly specialized knowledge of orientation with regard to an overall view of philosophical disciplines, to philosophy's interdisciplinary dialogue with other sciences and with special regard to the aim that philosophical thinking forms the basis of well-founded and scientifically reflected beliefs and enables to take a critically reflected position.
- (3) In accordance with these tasks and objectives the Master's Programme Philosophy at Faculties of Catholic Theology provides a specialized education in philosophy that takes into account the most important traditional strands of philosophy as well as representative contemporary positions; thus it can be viewed as the basis for innovative intellectual approaches. Emphasis is laid on the core subjects of Theoretical and Practical Philosophy, on a thorough analysis of the history of philosophy and on the analysis of the peculiarity of the rationality of world views and dialogue on world views.
- (4) These contents and structures of the Master's Programme Philosophy at Faculties of Catholic Theology also define its fields of application and the professional qualifications achieved. A combination with a theological programme, in particular with the Diploma of Catholic Theology, presents itself as an enriching possibility. Moreover the Master's Degree also provides its own professional qualification in the sense of § 51 Para 2 No 4 UA 2002 for occupations that require leadership and coordination of complex and unforeseen concepts of work or learning. Special emphasis is placed on key qualifications, such as highly specialized orientation knowledge, the special ability analyse critically, and to argue in a plausible and academically responsible way, also in the areas of society and culture, the media and politics. The graduates are able to pursue tasks requiring higher and specialized qualifications in education, publishing and administration, in particular in ecclesiastical organizations. The Master's Programme provides opportunities for

contributing to interdisciplinary projects, for example in projects dealing with the fundamentals of particular sciences.

## **§ 2 Classification**

The Master's Programme Philosophy at Faculties of Catholic Theology is assigned to the group of theological study programmes.

## **§ 3 Scope and Duration**

The Master's Programme Philosophy at Faculties of Catholic Theology amounts to 120 ECTS-credits, which equals a duration of four semesters.

## **§ 4 Admission**

- (1) To be admitted to the Master's Programme Philosophy at Faculties of Catholic Theology the completion of a relevant Bachelor's programme at a university or a university of applied sciences or an equivalent study programme at an acknowledged university or post-secondary educational institution home or abroad is required. If equivalency is given in principle, and only a few elements are missing for full equivalency, the rector's office is entitled to combine the equivalency with the obligation to pass certain examinations during the course of the master's programme.
- (2) The Bachelor's Programme Philosophy at Faculties of Catholic Theology at the University of Innsbruck is in any case a relevant study programme in the sense of paragraph 1.

## **§ 5 Types of courses and maximum number of participants**

- (1) Courses without continuous performance assessment:

**Lectures** (VO) are courses held in lecture format. They introduce the research areas, methods and schools of thought for a given subject. Maximum number of participants: 126

- (2) Courses with continuous performance assessment:

1. **Lectures with practical elements** (VU) focus on the practical treatment of concrete scientific tasks that are discussed during the lecture parts of the course. Maximum number of participants: 126

2. **Seminars** (SE) provide in-depth treatment of scientific topics through students' presentations and discussion thereof. Maximum number of participants: 20

## **§6 Admission procedures for the admission to courses with a limited number of participants**

Students, the study time of whom would be prolonged without admission to the course, are given priority for admission.

## § 8 Master's Thesis

- (1) The Master Thesis is to document the ability to independently work on a philosophical topic in a methodologically and thematically responsible way.
- (2) The topic of the Master's Thesis has to be thematically connected to one of the compulsory modules 1 to 9. When registering the Master's Thesis, the choice of the elective module 1, 2 or 3 must be announced.
- (3) The Master's Thesis amounts to a workload of 27.5 ECTS-Credits.
- (4) The Master's Thesis has to be submitted in writing and in an electronic form to be determined by the Dean of Studies.

## § 9 Examination Regulations

- (1) Each module is completed by the positive evaluation of the individual courses by course examinations.
- (2) In the case of course examinations for lectures the lecturer has to determine and announce the examination method (oral and/or written) before the start of the course.

- (3) In courses with continuous performance assessment, the criteria of examination, which have to include a written paper, have to be determined and announced by the lecturer before the start of the course.
- (4) The final Defense of the Master's Thesis takes approximately 30 minutes per student. It is an oral examination to be graded by the reviewer of the Master's Thesis.

## § 10 Academic Degree

The graduates of the Master's Programme Philosophy at Faculties of Catholic Theology receive the degree "Master of Philosophy", abbreviated „M.phil.“.

## § 11 Coming into force

- (1) This curriculum comes into force on October 1, 2009.
- (2) The modification of the curriculum as published in the University of Innsbruck Bulletin of 31 May 2012, Issue 29, No. 311 comes into force on 1 October 2012 and is valid for all students.
- (3) The changes of the curriculum in the version of the University of Innsbruck Bulletin of 7 May 2015, Issue 35, No. 399 are effective as of 1 October 2015 and are to be applied to all students.
