at the Faculty of Humanities 1 of the University of Innsbruck

§ 1 Qualification Profile

(1) The Master of Arts programme in Philosophy is included in the group of study programmes of Humanities and Cultural Sciences.

(2) The Master of Arts programme in Philosophy complements the Bachelor of Arts programme in Philosophy including further sub-disciplines of Philosophy, consolidating the students' philosophical knowledge in terms of Theoretical Philosophy and Practical Philosophy as well as emphasizing Intercultural Philosophy and Applied Ethics. It leads to independent, critical examination of the development of history of ideas and culture as well as contemporary currents of Philosophy. The interests developed during the Bachelor of Arts programme may be followed further and related to other questions. Besides, the necessary skills for scientific work in the field of Philosophy are completed and perfected. This applies especially to the skill of analysing philosophical texts against the background of History of Philosophy and in the context of state-of-the-art discussions in research, to scrutinize them independently and to link them to current social and intercultural problems. The students are supported in developing their own questions and solutions for problems, presenting them in writing or orally and to argue for them.

(3) Apart from specialist skills for the discipline, the Master of Arts programme in Philosophy provides and consolidates a rather large number of non-subject-specific skills. They include critical problem awareness and the competence of solving problems methodically, tapping new and uncommon fields of work independently, analyse, compare and modify arguments and opinions critically, categorise the most diverse kinds of text and material adequately as well as expressing oneself clearly and precisely in oral and written form. Also the skill to present complex circumstances in an abridged form reducing them to the essential thoughts and logical connections is provided.

(4) The Master of Arts programme in Philosophy serves further scientific education and besides is a prerequisite for a Ph.D. study programme. It provides especially knowledge and skills that facilitate professional perspectives in different fields of occupation. Graduates of the Master of Arts programme in Philosophy are characterised by being able to deal with new challenges and to apply their analytical and communicative skills in different areas. Their actual job opportunities also depend on additional qualifications and personal engagement. Typical fields of occupation for philosophers are found at universities or in their environment, in scientific, cultural and social fields, in the media as well as in politics and business.

§ 2 Length and Scope

The Master of Arts programme in Philosophy includes 120 ECTS credits (hereinafter abbreviated as ECTS-AP) and thus has a duration of four semesters.

§ 3 Admission

(1) The admission requirement for the Master of Arts programme in Philosophy is having completed a relevant bachelor's programme at a university or university of applied sciences or an equivalent study programme at a recognised post-secondary educational institution in Austria or abroad.

(2) In any case, the bachelor's programme in Philosophy at the Faculty of Humanities 1 of the University of Innsbruck and the bachelor's programme in Philosophy at the Faculty of Catholic Theology at the University of Innsbruck are considered relevant study programmes according to section 1.

(3) If the study programme completed is equivalent in principle and only certain addenda are needed for full equivalence, the Rectorate has the right to link the recognition of full equivalence to certain examinations to be taken during the Master of Arts programme.

§ 4 Types of courses and maximum number of participants

(1) **Lectures (VO)** deal with main and/or specific topics as well as relevant methods and opinions.

(2) Courses assessed via continuous assessment:

1. **Lectures with tutorials (VU)** are used for systematic acquisition, application and consolidation of scientific content. The number of participants is unlimited.
2. **Seminars (SE)** are courses for advanced scientific discussion. The participants are required to perform scientific work independently, particularly in form of a presentation and a written piece of work or equivalent performances. Maximum number of participants: 30.
3. **Courses (KU)** are classes for which students are expected to prepare the subject mainly independently. It is possible to combine course parts with compulsory attendance on the one hand and virtual learning on the other hand. Maximum number of participants: 25.
4. **Research seminars (FO)** are used for joint work on a concrete scientific topic and practising independent research as well as scientific co-operation in a group. Maximum number of participants: 15.

§ 5 Allocation procedure for courses with a limited number of participants

Admission to courses with a limited number of participants is allocated as follows:

(1) Students who would suffer a prolongation of their studies if not admitted shall be admitted preferentially.

(2) If criterion 1 is insufficient in order to regulate admission to a certain course, students for whom the course in question is part of a compulsory module shall take precedence over those for whom the course is part of an elective module.

(3) If criteria 1 and 2 are insufficient in order to regulate admission to a certain course, admission is allocated by lottery.

§ 8 Master's Thesis

- (1) Within the Master programme, a Master's Thesis with a scope of 27.5 ECTS-AP shall be elaborated. The Master's Thesis is a scientific piece of work that proves the ability to work on a scientific topic independently and in a justifiable way in terms of content and methodology.
- (2) The topic of the Master's Thesis shall be taken from the field of Philosophy.
- (3) The student has the right to propose a topic for his/her Master's Thesis or choose a topic out of a number of proposals.
- (4) The student has the right to write his/her Master's Thesis in a foreign language if the supervisor's consent is provided.
- (5) The Master's Thesis has to be presented in writing as well as in the electronic form specified by the Director of Studies.

§ 9 Examination Regulations

- (1) All modules except the module Master's Thesis Defense are completed by successful completion of the courses included.
- (2) Course examinations are:
 1. Examinations that prove the knowledge and skills provided by a certain lecture, with the assessment taking place in a single examination at the end of the lecture. Before starting the course, the course lecturer shall specify and declare which type of examination (written and/or oral) will take place.
 2. Courses assessed via continuous assessment, which are assessed according to the participants' regular written and/or oral contributions. Before starting the course, the course lecturer shall specify and publish the assessment criteria.
- (3) The assessment of the final module Master's Thesis Defense shall take place in form of an oral examination in front of an examination board of three examiners.

§ 10 Academic Degree

The academic degree "Master of Arts", abbreviated as "MA" shall be conferred upon graduates of the Master programme in Philosophy.

§ 11 Coming into force

This curriculum comes into force on 1 October 2010.

§ 12 Temporary Dispositions

- (1) Upon coming into force, degree students who started the Master's programme in Philosophy before this curriculum came into force have the right to finish their studies within five semesters.
- (2) If they do not finish the former Master's programme on time, the students become subject to this curriculum of the Master of Arts programme in Philosophy. Besides, they are entitled to volunteer for this curriculum at any earlier point in time.
