Curriculum for the

### **Doctor of Philosophy Programme Political Science**

at the Faculty of Social and Political Sciences of the University of Innsbruck

#### **§ 1 Qualification profile**

- (1) The Doctor of Philosophy Programme Political Science belongs to the group of studies in the social and economic sciences.
- (2) Graduates of the Doctor of Philosophy Programme Political Science mostly conduct theoretical and empirical research in political science and integrate their findings into the national and international research process by means of publications. Graduates of this programme are able to teach in the field of political science and to advance the development of theoretical and empirical research methods.
- (3) Graduates of the Doctor of Philosophy Programme Political Science will pursue careers, among others, at universities, in research institutions, and in other post-secondary educational institutions. They are capable of working in managerial positions in research institutions of national, transnational, and international organizations, with governmental and non-governmental interest groups, and for political institutions and the media.
- (4) Graduates of the Doctor of Philosophy Programme Political Science possess the competences and knowledge to write scientific contributions according to international research standards and to integrate them into the international research process, especially through their dissertation as independent research work. They are in a position to develop research projects independently and creatively, to successfully submit them to national and international research funding institutions, and to carry them out. Within their special field, they are able to communicate with the scientific community, to present their own research results in society, and to work on and discuss issues in an inter-disciplinary manner.

#### **§ 2 Length and duration**

The Doctor of Philosophy Programme Political Science takes three years (six semesters). This equals 180 ECTS-Credits.

### § 3 Admission

- (1) Valid proof of the necessary academic level for admission to the doctoral programme must be provided. This includes proof of completion of relevant diploma or master programmes, of relevant diploma or master programmes at a university of applied sciences or other equivalent studies at an accredited Austrian or non-Austrian post-secondary educational institution. If equivalency is given in principle, and only a few elements are missing for full equivalency, the rector's office is entitled to combine the determination of equivalency with the obligation to pass certain examinations in the course of the doctoral programme.
- (2) Relevant studies are in any case
  1. the Diploma Programme in Political Science at the University of Innsbruck,
  2. the Master Programme "European Politics and Society" and the Master Programme "Political Science: European and International Studies" at the University of Innsbruck.

### § 4 Types of courses and maximum number of students per course

Courses without continuous assessment:

1. Lectures with integrated practical and discussion parts (VU) focus on the practical treatment of concrete scientific tasks that are discussed during the lecture parts of the course. Maximum number of participants: 20
2. Seminars (SE) provide in-depth treatment of scientific topics through students' presentations and discussion thereof. Maximum number of participants: 20

### § 5 Allocation of places in courses with a limited number of participants

Students whose study time will be prolonged if they are not admitted are to be given priority.

## § 7 Dissertation

- (1) In the course of the doctoral programme, a dissertation has to be written, which equals 150 ECTS-Credits. The dissertation is a piece of scientific work which – in contrast to a diploma or master thesis – serves to prove the student's ability to cope with scientific questions in an independent manner.
- (2) The dissertation topic is to be chosen from the field of political science.
- (3) The student has to propose a team of supervisors consisting of at least two people (dissertation committee) and to nominate one of them as the supervisor mainly responsible (with a *venia doctendi*). It is permissible to propose supervisors (with the exception of the main supervisor) from subject-related fields. In justifiable exceptional cases it is possible for students to propose only one supervisor.

- (4) The student has to communicate the dissertation topic and the names of the supervisors in writing to the Director of Studies prior to beginning the work. Topic and supervisors are considered as accepted, if the Director of Studies does not veto them by means of a decree within one month after the receipt of the proposal.

#### **§ 8 Examination regulations**

- (1) The evaluation of a module with one or several courses with continuous assessment is based on the student's regular written and oral contributions. The lecturer is required to communicate the evaluation criteria before the course starts.
- (2) Compulsory modules 1 and 2 are evaluated by the Director of Studies on the basis of a performance report written by the student. A positive grade has to read "participated with success"; a negative grade has to read "participated without success".
- (3) The evaluation of compulsory module 3 (Doctoral Thesis Defense) is based on an oral exam taken before an examination board consisting of three examiners.

#### **§ 9 Academic degree**

Graduates of the Doctor of Philosophy Programme Political Science are awarded the academic degree of "Doctor of Philosophy", abbreviated as "PhD".

#### **§ 10 Coming into force**

- (1) This curriculum comes into force on 1 October 2009.
- (2) The modification of the curriculum published in the University of Innsbruck Bulletin of 17 June 2014, Issue 30, No 504 comes into force on 1 October 2014 and applies to all students.
- (3) The changes of the curriculum in the version of the University of Innsbruck Bulletin of 3 April 2017, Issue 30, No. 400 come into effect on 1 October 2017 and are to be applied to all students.
- (4) The changes of the curriculum in the version of the University of Innsbruck Bulletin of 5 April 2019, Issue 26, No. 370 come into force as of 1 October 2019 and are to be applied to all students.
