## INTERNATIONAL STUDENTS STATEMENT OF FINANCIAL SUPPORT

**Purpose of the requirements:** Universities in the United States are required by the U.S. Immigration and Customs Enforcement (ICE) to have documentary proof of adequate financial support before they may admit an international student. This form must be accompanied by official bank statement or letter including account balance(s) of liquid funds. Failure to accurately and fully complete this form may result in non-issuance of the U.S. Government form (I-20 or DS 2019) which is required (1) to obtain a visa and enter this country or (2) to legally transfer from another U.S. school to the University of New Orleans.

You should expect to spend approximately \$35,660 for undergraduate, \$36,260 for graduate (MBA \$39,468) per each academic year (August through May) to cover tuition, dormitory or apartment, meals, books, mandatory health insurance, and other miscellaneous expenses. If you plan to bring your spouse or children, you should allot an additional \$3,000 per year for each dependent. These are conservative estimates and will not necessarily cover unexpected expenses which may arise during the year and any travel you might wish to undertake during your stay in the U.S. All students are required to purchase and maintain adequate health insurance for the duration of their stay in the United States.

### U.S. Employment and Financial Aid

**On-campus employment:** Please note that on-campus jobs are few in number and difficult to obtain. If you are not awarded a graduate assistantship (Master's and PhD. candidates only) or some other form of financial assistance by the University at the time you are notified of your admission, we cannot guarantee that you will find a job once you arrive on campus. International students may only be employed by departments who hire student workers out of their own budgets, of which there are few. Financial support, other than graduate assistantships and scholarships, is generally not available to international students.

**Off-campus employment:** It is a violation of immigration regulations for international students to be employed off the university campus without first obtaining written work authorization from the Office of International Students and Scholars. This permission is not easily obtained. International students should therefore not expect to supplement income from their financial sponsors by working off campus.

**Graduate students requesting financial assistance:** Independent financial documentation is required but will not have an effect on whether you are offered an award. Awards are based upon merit, not need. Graduate assistantships and other awards do not cover all estimated expenses. You should verify the maximum amount of funds available or, if possible, U.S. \$35,660/year undergraduate or \$36,260 graduate (MBA \$39,468). Add U.S. \$3,000 for each dependent.
