# § 1 Allocation of the study programme

According to §54 para. 1 of the Universities Act of 2002, the Master's Programme in Political Science at the University of Innsbruck is grouped among the social and economic study programmes.

# § 2 Qualification profile

- (1) The Master's Programme in Political Science provides in-depth professional training in social and political science and qualification for professional activities that require the application of advanced scientific knowledge and methods. As an academic degree programme, its core consists of the specialised teaching of theories, methods and instruments of social and political sciences and, in particular, the study of political orders, institutions, actors and processes at national, regional, European and global level.
- (2) The aim of the university master's programme is to provide graduates with in-depth scientific and academically sound, theory- and method-based analysis and problem-solving skills in science and practice. Graduates have the knowledge, skills and competences to
  - work independently on scientific problems, assess scientific knowledge and apply it in new, particularly research-relevant contexts, as well as undertake further scientific doctoral or PhD studies;
  - work on relevant problems in their respective non-university professional fields in a scientifically sound and practice-orientated manner. Beyond the subject of political science, they have knowledge, skills and competences that enable them to work in various professional fields:
  - take responsibility for the professional development and management of individuals and groups;
  - use their competences for the prosperous development of society and to improve the quality of life in a community by means of political and non-political processes;
  - reflect on the ethical, social, gender and diversity-related and societal consequences and prerequisites of the use of their knowledge.
- (3) In addition to subject-specific skills, the Master's Programme in Political Science also promotes interdisciplinary social skills such as research skills, written and verbal communication skills, teamwork and social commitment in its modules. In addition, general qualifications are taught and deepened. These include:
  - the ability to present the facts arising from the sources in a critical, factual and clear manner,
  - the ability to combine analytical, critical, creative and design thinking,
  - the competence to create scripts in common computer programmes that are used in the context of social science methods (e.g. R or Python),
  - the competence to create data visualisations that communicate complex content in an appealing, understandable and correct way.
- (4) The Master's Programme in Political Science prepares students in particular
  - for work in scientific organisations and institutions and in particular for taking up a further scientific doctoral or PhD programme and/or
  - for managerial, analytical, planning, auditing and advisory work in public administration, in non-governmental and governmental organisations (such as the European Union, the United Nations, etc.), in companies or in transnational party or interest groups.

#### § 3 Admission

- (1) Admission to the Master's Programme Political Science requires a completed bachelor's degree in a subject-relevant subject or completion of a comparable subject-relevant study programme at a recognized national or international postsecondary educational institution.
- (2) In any case, the Bachelor's Programme in Political Science passed at the University of Innsbruck is a subject-relevant study programme. The Rectorate decides on the relevance of another subject-relevant study programme pursuant to \$64 para. 3 Universities Act.
- (3) In order to compensate for significant subject-related differences, supplementary examinations totalling a maximum of 30 ECTS-Credits may be prescribed, which must be taken by the end of the second semester of the master's programme.
- (4) The following qualitative admission requirements pursuant to §63a para. 1 Universities Act also apply: knowledge in the field of political science sub-disciplines and social science methods. In any case, this knowledge is demonstrated by positively assessed course examinations totalling 20 ECTS-Credits from the core areas of "European Union", "International Relations", "Political Theory" and "Comparative Politics" as well as 10 ETCS-Credits from the area of 'Methods of Empirical Social Research' and 'Statistics'.

#### § 4 Scope and duration

The Master's Programme Political Science covers 120 ECTS-Credits; this corresponds to a duration of four semesters. One ECTS-Credit is equivalent to a workload of 25 hours.

#### § 5 Types of courses and maximum number of students per course

- (1) Courses without continuous performance assessment:
  - Lectures (VO) are courses held in lecture format. They introduce the research areas, methods and schools of thought for a given subject. No maximum number of students per course.
- (2) Courses with continuous performance assessment:
  - 1. Seminars (SE) provide in-depth study of contents, methods and techniques of a specialist area including presentations and discussions. Maximum number of students: 30.
  - 2. Lecture-tutorials (VU) focus on the practical treatment of concrete scientific tasks that are discussed during the lecture parts of the course. Maximum number of students: 60

# § 6 Allocation of places in courses with a limited number of participants

In courses with a limited number of participants, the places are allocated as follows:

- 1. Students for whom the study duration would be extended due to the postponement are given priority.
- 2. If the criterion in no. 1 does not suffice, first, students, for whom this course is part of a compulsory module are to be given priority, and second, students of for whom this course is part of an elective module.
- 3. If the criteria in no. 1 and no. 2 do not suffice, the available places are randomly raffled.

### § 7 Structure of the study programme

Within the scope of the Master's Programme in Political Science, compulsory modules covering 30 ECTS-Credits as well as a compulsory specialisation covering 60 ECTS-Credits incl. the Master's Thesis (CM 3 with 2.5 ECTS-Credits, CM 4 with 2.5 ECTS-Credits and 25 ECTS-Credits Master's Thesis) are to be passed. The following Specialisations are offered:

- European Integration Policy: elective modules 1 to 3
- International Relations: elective modules 4 to 6
- Comparative Political Science: elective modules 7 to 9

In addition, further elective modules covering 30 ECTS-Credits are to be passed.

# § 8 Compulsory and elective modules

(1) The following compulsory modules covering altogether 30 ECTS-Credits are to be passed:

#### **Learning Outcomes:**

Students have a sound overview of theoretical and analytical concepts, empirical findings and methodological challenges of analysing political governance and political system comparisons in national, international and supranational contexts as well as party and election research. They are able to analyse and evaluate specific characteristics and functions of political systems and their inherent dynamics on the basis of theory.

In addition, students have basic knowledge of programming and visualisation. They are able to graphically visualise data relevant to political science with the help of programming languages such as R or Python. They can structure research results and scientific working methods in a clear, coherent and comprehensible manner and communicate this knowledge both orally and in writing in a way that is appropriate to the situation, function, domain and target group.

They understand the background of these methods in philosophy of science, logic or statistics and their implications for data collection, data management and data analysis. They understand how to select quantitative and qualitative methods that are appropriate to answer their research questions or significant research questions in the discipline. They know how to collect appropriate data to apply these methods and can describe the advantages and disadvantages of the methods used, evaluate them empirically and present their research findings in the context of these advantages and disadvantages. Finally, students understand how to document the methods used in such a way that their work is transparent and can be replicated.

# **Learning Outcomes:**

Students are able to analyse and apply theory and empiricism in the cross-sectional subjects of political economy and empirical gender studies as well as in the fields of inequality and representation. Students are familiar with the most important subjects, concepts, theories and methods of political economy and the basic functional mechanisms of economic systems (especially the market economy), have basic knowledge of the possibilities and limits of political control of different types of economic systems, their political prerequisites and social consequences, as well as the theories and methods of the new political economy (e.g. game theory).

Students are able to apply the central concepts and topics of empirical gender studies in political science. They have a multidimensional understanding of the relationship between gender and politics and the importance of gender for analysing political processes. They are thus able to conduct empirical analyses of political processes and policy fields from a gender perspective. They are familiar with the latest research on political, economic and social inequality and representation.

(3) Courses amounting to 10 ECTS-Credits must be selected from the non-selected specializations.

(4) Further elective modules covering 30 ECTS-Credits are to be passed.

Instead of the elective modules pursuant to §8 para. 3 a Minor for master's programmes may be passed, provided that places are available. Minors are fixed modules from other disciplines covering 30 ECTS-Credits. They have been announced in the University of Innsbruck Bulletin.

#### § 9 Master's Thesis

- (1) In the Master's Programme in Political Science, a Master's Thesis covering 25 ECTS-Credits must be written in the area of the chosen specialisation. The Master's Thesis is a piece of academic work that serves to demonstrate the student's ability to work independently on an academic topic in a substantively and methodologically sound manner.
- (2) The Master's Thesis must be submitted in electronic form or in the form specified by the Director of Studies.
- (3) If the supervisor agrees to it, the Master's Thesis may be written in a foreign language.

#### § 10 Examination regulations

(1) A module, with the exception of the modules "Preparation of the Master's Thesis" and "Master's Thesis Defence" as well as modules "Political Science in Practice I" and "Political Science in Practice II" is completed by positive evaluation of its courses.

The performance in courses of the modules is assessed by course examinations. Course examinations serve to proof the knowledge and skills imparted by a single course whereby

- 1. in the case of courses without continuous performance evaluation, the evaluation is based on a single exam at the end of the course.
- 2. in the case of courses with continuous performance evaluation the evaluation is based on at least two written, oral and/or practical contributions of the participants.
- (2) The course instructor has to define and announce the examination method (written and/or oral, exam paper) and the evaluation criteria before the start of the semester.
- (3) The performance in the modules "Political Science in Practice I" and "Political Science in Practice II" is evaluated by the Director of Studies. Positive evaluation reads "participated with success", negative evaluation "participated without success".
- (4) The performance evaluation of the Compulsory Module "Preparation of the Master's Thesis" is carried out by the supervisor on the basis of the research design. Positive evaluation reads "participated with success", negative evaluation "participated without success".

- (5) The evaluation of the final module of the study programme "Master's Thesis Defence", which also completes the study programme, is based on an oral exam before an examination board consisting of three persons.
- (6) Modules and courses taken from other study programmes are subject to the examination regulations of the curriculum they have been taken from. Extra-curricular Minors are subject to the examination regulations of this curriculum.

### § 11 Academic Degree

Graduates of the Master's Programme Political Science are awarded the academic degree "Master of Arts", abbreviated "MA".

# § 12 Coming into force

This curriculum is effective as of 1 October 2024.

#### § 13 Transitional provisions

- (1) This curriculum applies to all students who start the study programme from the 2024/25 winter semester onwards.
- (2) Regular students who have started the Master's Programme in Political Science: European and International Politics, published in the University of Innsbruck Bulletin of 19 February 2008, Issue 20, No. 187 at the University of Innsbruck before 1 October 2024, are entitled to finish this study programme within a maximum of six semesters from this point in time.
- (3) If the Master's Programme in Political Science: European and International Politics is not finished in time pursuant to para. 2, the students are subject to the curriculum for the Master's Programme in Political Science (New-release 2024).
- (4) The students of the Master's Programme in Political Science: European and International Politics are entitled to subject to the curriculum for the Master's Programme in Political Science on a voluntary basis any time.
