Curriculum for the **Bachelor's Programme Music Studies**

at the Faculty of Philosophy and History at the University of Innsbruck

§ 1 Qualification profile

- (1) The Bachelor's Programme Music Studies is allocated to the group of the Humanities and Cultural Studies.
- (2) Graduates of the bachelor's programme have basic knowledge in all sub-areas of the discipline of music studies, whereby the focus lies on the area of historical music studies. Graduates are able to independently obtain and assess subject-specific information. They are able to adapt scientific findings for professional practice. They are guided to a targeted reflection of their own culturally shaped personal approach, which is a prerequisite for the critical evaluation of music and statements about music. Furthermore, they acquire the competence to process scientific findings in a generally understandable form and to communicate them orally and in writing, to work bibliographically and documentarily as well as to deal with the technical media necessary for the communication of scientific facts and findings.
- (3) Possible professional fields of graduates:
 - 1. music collections and music-related documentation facilities of all kinds (libraries, archives, museums, music information centres),
 - 2. media (radio, television, print media, internet),
 - 3. cultural management (event and mediation management)
 - 4. dramaturgy,
 - 5. cultural industry (publishing houses, recording industry),
 - 6. cultural administration and cultural policy

§ 2 Scope and duration

The Bachelor's Programme Music Studies covers 180 ECTS-Credits. This corresponds to a duration of the study programme of six semesters. One ECTS-Credit corresponds to a workload of 25 hours.

§ 3 Types of courses and maximum number of participants per course

- (1) Courses with continuous performance assessment:
 - 1. **Lectures (VO)** are courses held in lecture format. They introduce the research areas, methods and schools of thought for a given subject.
 - 2. **Studies induction and orientation courses (SL)** provide an overview of the main contents of the programme and its structure so that students have an objective basis to assess their decision to pursue the respective field of study. Maximum number of participants: 30.

- (2) Courses with continuous performance assessment:
 - Lectures with practical elements (VU) focus on the practical treatment of concrete scientific
 tasks that are discussed during the lecture parts of the course. No maximum number of students
 per course.
 - 2. **Introductory seminars** (PS) introduce students interactively to scientific literature through the treatment of selected issues. They convey knowledge and methods of academic work. Maximum number of participants: 30
 - 3. **Seminars** (SE) provide in-depth treatment of scientific topics through students' presentations and discussion thereof. Maximum number of participants: 30
 - 4. **Practical courses** (UE) focus on the practical treatment of concrete scientific tasks within an area. Maximum number of students per course: 30

§ 4 Allocation of places in courses with a limited number of participants

In courses with a limited number of participants, the places are allocated as follows:

- 1. Students for whom the study duration would be extended due to the postponement are to be given priority.
- 2. If the criterium in no. 1 does not suffice, then first students who take this course as part of a compulsory module and secondly students for whom this course is part of an elective module are given a place.
- 3. If the criteria in no. 1 and no. 2 do not suffice to regulate the admission, then the available places are drawn at random.

§ 5 Compulsory and elective modules

6. Individual Choice of Specialisation (max. 20 ECTS-Credits)

For individual specialisation, modules from the curricula of the bachelor's and/or diploma programmes (incl. of this bachelor's programme) offered at the University of Innsbruck acc. to §54 par. 1 Universities Act covering a maximum of 20 ECTS-Credits may be freely selected. The prerequisites specified by the respective curricula must be met.

§ 6 Studies Induction and Orientation Stage

- (1) Within the scope of the Studies Induction and Orientation Stage, to be completed in the first semester, the following course examination is to be passed.
 - 1. SL Introduction to Historic and Systematic Musicology (CM 1 lit. a/4 h/10 ECTS-Credits)
 - 2. SL Introduction to the Ethnology of Music (CM 1 lit. b/2 h/5 ECTS-Credits)
- (2) The successful passing of all examinations in the Studies Induction and Orientation Stage entitles to pass all further courses and examinations as well as to writing the Bachelor's Thesis.
- (3) Before the Studies and Orientation Stage has been completed, courses covering a maximum of 15 ECTS-Credits may be passed. The prerequisites specified by the respective curricula must be met.

§ 7 Bachelor's Thesis

- (1) In the Bachelor's Programme Music Studies, a Bachelor's Thesis corresponding to 16 ECTS-Credits is to be written.
- (2) The Bachelor's Thesis must be written within the scope of courses with continuous performance assessment from the compulsory modules 3 to 8 and 10 and are supervised by the respective course lecturer. The Bachelor's Thesis must be written in addition to the course within the scope of which it is written.
- (3) The Bachelor's Thesis is to be handed in in writing as well as in the electronic form specific by the Director of Studies.

§ 8 Examination regulations

- (1) The performance of a module (module examination) is based on course examinations.
- (2) Course examinations are:
 - 1. examinations that assess the knowledge and skills covered in an individual lecture or course of the studies induction and orientation stage and in which the performance assessment is based on a single examination at the end of the course. The course instructor has to define and announce the examination method (written and/or oral) before the start of the course.
 - 2. courses with continuous assessment, for which course assessment is based on regular written and/or oral contributions by participants. The course instructor has to define and announce the evaluation criteria before the start of the course.

3. Positive evaluation of elective modules 1 (Artistic Practice I and II) and 2 (Artistic Practice III) and 2 (Artistic Practice III) reads "successfully completed", negative evaluation "unsuccessfully completed").

§ 9 Academic degree

Graduates of the Bachelor's Programme Music Studies receive the academic degree "Bachelor of Arts", abbreviated "BA".

§ 10 Coming into force and ceasing to be in force

This curriculum (re-enactment 2022) comes into force on 1 October 2022.

§ 11 Transitional provisions

- (1) This curriculum (curriculum 2022) applies to all students commencing the study programme as of the 2022/23 winter semester.
- (2) Regular students, who have started the Bachelor's Programme Music Studies, University of Innsbruck Bulletin of 23 June 2010, Issue 39, No. 324 (in the following referred to as curriculum 2010) before 1 October 2022, are entitled from this point in time to finish this study programme (curriculum 2010) within a maximum of eight semesters.
- (3) If the bachelor's programme (curriculum 2010) is not finished in time, the students are subject to the curriculum for the Bachelor's Programme Music Studies (curriculum 2022), published in the University of Innsbruck Bulletin of 28 June 2022, Issue 58, No. 610. Furthermore, the students are entitled to subject to the curriculum for the Bachelor's Programme Music Studies (curriculum 2022), published in the University of Innsbruck Bulletin of 28 June 2022, Issue 58, No. 610 on a voluntary basis at any time.
- (4) Corresponding lists of equivalence are to be published in the university bulletin by the Director of Studies.
