Curriculum for the **Doctor of Philosophy Programme Sociology** 

at the School of Political Science and Sociology of the University of Innsbruck

#### § 1 Qualification Profile

- (1) The Doctor of Philosophy Programme Sociology belongs to the group of studies in the social and economic sciences.
- (2) Graduates of the Doctor of Philosophy Programme Sociology are able to structure sociological issues theoretically and according to the current state of the discipline and to work on them in a methodically suitable manner. Therefore, they are able to pursue academic careers and/or assume preparatory tasks for planning and decision-making at the interfaces of science and practice in a modern "knowledge society" that require in-depth familiarity with scientific issues and procedures.
- (3) The Doctor of Philosophy Programme Sociology serves to educate and train researchers as well as highly qualified professionals according to international research standards for the public sector, the private and not-for-profit sector, as well as for national and, increasingly, international organizations. Correspondingly, graduates can pursue careers in university and non-university research facilities, in politics and business consulting, in market and opinion research, as well as in public relations, in the area of human resource and social management, in the management of data and symbolic analyses, and in cultural, educational, and media-related institutions.
- (4) The educational objective of this program is the competence to carry out independent and creative scientific work with scientific integrity, which is documented by the dissertation as an independent piece of scientific work. In addition to acquiring specialized subject knowledge and creating an increase in knowledge, the programme aims at the acquisition of key qualifications. These include the following competences: in-depth theoretical reflection, self-organized learning, subject-specific discussion, interdisciplinary dialog, the presentation of the student's own research results, and knowledge transfer.
- (5) The educational and training objectives of the Doctor of Philosophy Programme Sociology include gender competence. The current state of gender research is integrated in all modules as a cross-subject topic and is also the subject of an elective course.

#### § 2 Length and scope

The Doctor of Philosophy Programme Sociology takes three years (six semesters), which equals 180 ECTS-Credits.

#### § 3 Admission

- (1) Valid proof of the necessary academic level for admission to the doctoral programme must be provided. This includes proof of completion of relevant diploma or master programmes, of completion of relevant diploma or master programmes at a university of applied science or completion of other equivalent studies at an accredited Austrian or non-Austrian post-secondary educational institution. If equivalency is given in principle, and only a few elements are missing for full equivalency, the rector's office is entitled to combine the determination of equivalency with the obligation to pass certain examinations in the course of the doctoral program.
- (2) Relevant studies include, in any case, the Master Programme in Social and Political Theory of the University of Innsbruck.

#### § 4 Types of courses and maximum number of students per course

Seminars (SE) are courses with continuous performance assessment and serve to in-depth scientific examination with the presentation and discussion of articles by the students. Maximum number of participants: 20

### § 5 Procedure for the allotment of places in courses with a limited number of participants

Students whose study time will be prolonged if they are not admitted are to be given priority.

## § 6 Compulsory and elective modules

(1) The following compulsory modules with a total of 15 ECTS-Credits are to be taken:

In the course of the dissertation project, under guidance of the dissertation committee and in dialog with each other, students acquire the following competences: they identify unsolved problems of sociology in the context of current theory debates, develop an appropriate strategy for solving the problem by drawing on the ensemble of sociological methods, and make an independent contribution to the problem solution by implementing the solution strategy. After the successful completion of this module, they are able to plan, carry out, and critically evaluate a research project independently. Simultaneously, they acquire the skill to communicate scientific theories, methods, and findings in a suitable way. They are able to write a synopsis of their dissertation project and as a second step, present an interim report of their dissertation project (current state of research) at the institute.

# § 7 Dissertation

- (1) In the course of the Doctor of Philosophy Programme Sociology, a dissertation has to be written, which equals 145 ECTS-Credits. The dissertation is a piece of scientific work which in contrast to a diploma or master thesis serves to prove the student's ability to cope with scientific questions in an independent way.
- (2) The dissertation topic has to be chosen from the field of sociology.
- (3) The student has to propose a team of supervisors consisting of at least two people (dissertation committee) and to nominate one of them as the supervisor mainly responsible (with a venia docendi). It is permissible to propose supervisors (with the exception of the main supervisor) from subject-related fields. In justifiable exceptional cases it is possible for students to propose only one supervisor.

(4) Prior to beginning the work, the student has to communicate the dissertation topic and the names of the supervisors in writing to the Director of Studies. Topic and supervisors are considered as accepted, if the Director of Studies does not veto them by means of a decree within one month after the receipt of the proposal.

# § 8 Examination regulations

- (1) The evaluation of compulsory module 1 and elective modules 4 to 7 is based on course examinations.
- (2) The evaluation of courses with continuous assessment is based on the student's regular written and oral contributions. The lecturer is required to communicate the evaluation criteria before the course starts
- (3) A positive evaluation of compulsory module 1 "Disciplinary Competence Dissertation Project" has to read "participated with success"; a negative grade has to read "participated without success".
- (4) Elective modules 1 to 3 "The Dissemination and Communication of Scientific Results" are evaluated by the main supervisor on the basis of a scientific contribution accepted for publication or presentation submitted by the student. A positive grade has to read "participated with success"; a negative grade has to read "participated without success".
- (5) The evaluation of the compulsory module 2 (Doctoral Thesis Defense) is based on an oral exam taken before an examination board consisting of three examiners.

# § 9 Academic degree

Graduates of the Doctor of Philosophy Programme Sociology are awarded the academic degree of "Doctor of Philosophy" or "PhD", in brief.

#### § 10 Implementation

- (1) This curriculum comes into force on 1 October 2009.
- (2) The modification of the curriculum published in the University of Innsbruck Bulletin of 17 June 2014, Issue 30, No 505 comes into force on 1 October 2014 and applies to all students.
