§1 Allocation of the study programme

Pursuant to §54 Universities Act 2002, the Extension Programme Entrepreneurship is allocated to the group of social and economic study programmes.

§2 Admission

- (1) The admission to the Extension Programme Entrepreneurship requires admission to or completion of one of the following diploma or master's programmes:

- (2) For the admission to the Extension Programme Entrepreneurship a minimum of 120 ECTS-Credits must have been passed in the diploma programme to be extended.
- (3) If the admission to the regular study programme, the extension of which it serves, expires, the admission to the extension study programme shall also expire at the same time.

§3 Qualification profile

- (1) The Extension Programme Entrepreneurship at the University of Innsbruck is aimed at students and graduates of the programmes listed in §2 (1) who wish to expand their qualification profile through scientifically sound and practical additional training in the field of entrepreneurship.
- (2) Graduates of the Extension Programme Entrepreneurship understand central concepts of entrepreneurship and master methods and tools for the systematic implementation of a business idea. They are able to apply these additional entrepreneurship skills when founding their own start-ups. They are also able to apply these skills to the digital transformation of established companies or the development and introduction of innovative new products in companies.

§4 Scope and duration

The Extension Programme Entrepreneurship covers 30 ECTS-Credits. One ECTS-Credit corresponds to a workload of 25 hours.

§5 Language

The Extension Programme Entrepreneurship is offered in English. English language skills at level B2 (Common European Framework of Reference) are required. The regulations of the University of Innsbruck apply to the type of proof required.

§6 Types of courses and maximum number of students per course

Courses with continuous performance evaluation:

- 1. **Proseminars (PS)** introduce students interactively to a subject area and impart knowledge and methods of scientific working. Maximum number of students per course: 30
- 2. **Tutorials (UE)** focus on the practical treatment of specific tasks in a specialist area and on practicing specific skills. Maximum number of students per course: 30.
- 3. **Lectures-tutorials (VU)** focus on the practical treatment of concrete scientific tasks that are discussed during the lecture parts of the course. Maximum number of students per course: 30.

§7 Allocation of places in courses with a limited number of participants

In courses with a limited number of participants the places for participants are allocated as follows:

- 1. Students for whom the study duration would be extended due to the postponement are to be given priority.
- 2. If no. 1 is not sufficient to regulate the admission, the places will be raffled.

§8 Compulsory modules

The following compulsory modules covering a total of 30 ECTS-Credits are to be passed:

§8 Examination regulations

- (1) A module is completed by positive evaluation of its courses.
- (2) The courses of modules are evaluated by course examinations. Course examinations serve to demonstrate the knowledge and skills acquired in a single course. In courses with continuous performance assessment, participants are assessed on the basis of at least two written, oral and/or practical contributions.
- (3) The course instructors have to announce the examination method (written and/or oral, practical work) and the evaluation criteria before the start of the semester.

§9 Completion

The completion of the Extension Programme Entrepreneurship requires the completion of the regular study programme, which it extends. To document the completion of the extension programme, a certificate is issued.

§10 Coming into force

This curriculum comes into force on 1 October 2025.

§11 Transitional provisions

- (1) This curriculum applies to all students who start the Extension Programme Entrepreneurship from the 2025/26 winter semester onwards.
- (2) Regular degree students who have started the Extension Programme Entrepreneurship as published in the University of Innsbruck Bulletin of 15 September 2021, Issue 104, No. 1051 at the University of Innsbruck before 1 October 2025, are entitled to finish this study programme within a maximum of four semesters from this point in time.
- (3) If the Extension Programme Entrepreneurship is not completed in time, the students will be subject to this curriculum. In any case, the students may subject to this curriculum on a voluntary basis anytime.
